These raffles are conducted by Women in Need Society of Calgary in accordance with the AGLC Raffle Terms & Conditions and other relevant AGLC policies and procedures relating to these licences (the "AGLC Policy")

Terms & Conditions

### **1. Eligibility**

Tickets may be purchased only by individuals who are 18 years of age or older and located in Alberta at the time of purchase. Any ticket issued to a person who does not meet these requirements is void.

Board members, staff, volunteers directly involved in the conduct or management of the raffle, raffle administrators/managers, and their immediate family members are not eligible to purchase tickets or win prizes.

### **2. Ticket Sales**

Tickets will be sold online only through a licensed electronic raffle platform.

For each licence separately (Prize Raffle and 50/50), ticket packages and limits are:

1 ticket for \$10 - maximum 100 purchases

3 tickets for \$20 - maximum 200 purchases

10 tickets for \$50 - maximum 100 purchases

50 tickets for \$100 - maximum 100 purchases

Each licence has a maximum of 6,700 tickets available for sale. The Prize Raffle and the 50/50 Raffle are separate licences with identical, but independent, ticket allocations.

Ticket sales open April 27, 2026 at 12:00 a.m. MST and close June 26, 2026 at 11:59:59 p.m. MST.

All ticket sales are final except where cancellation or refund is required by law or AGLC Policy.

Ticket numbers will be issued electronically to the purchaser by the electronic raffle supplier. No paper ticket will be mailed.

### **3. Early Bird Deadline**

Tickets purchased by May 8, 2026 at 11:59:59 p.m. MST are eligible for the Early Bird Prize draw.

### **4. Draws**

All draws will be conducted using the registered electronic raffle supplier's random number generator and are open to the public.

### **5. Raffle Prizes and Draw Order**

## **6. Prize Conditions**

All prizes must be accepted as awarded and are not transferable, refundable, or redeemable for cash, unless expressly stated otherwise by the prize sponsor or organizer.

Sponsor-specific restrictions apply to certain prizes, including blackout dates, booking deadlines, service-area limits, and other redemption conditions.

## **7. Winning Ticket Eligibility for Later Prize Draws**

For the Prize Raffle, each sold ticket remains eligible for each draw of non-identical prizes, including the main prize draw after the early bird draw.

Tickets for the 50/50 Raffle apply only to the 50/50 draw and are not entries into the Prize Raffle.

## **8. Winner Notification and Claiming Prizes**

Winners will be notified using the contact information provided at purchase, first by email and then by phone if required.

Winners must claim their prize within three months of the applicable draw date.

To claim a prize, the winner must provide satisfactory proof of identity, including government-issued photo identification, and any additional information reasonably required to verify entitlement to the prize and complete raffle reporting requirements.

Each ticket may only have one person's name on it. If more than one name appears on a winning ticket, the prize will be awarded to only one of the named individuals. Neither Women in Need Society of Calgary nor the AGLC is responsible for any dispute that may arise between different individuals whose names appear on the tickets.

### **9. Unclaimed Prizes**

WINS will make reasonable efforts to contact the winner by email and phone. Winners are encouraged to respond within 7 days of notification. However, prizes must be claimed for within three months of the draw date, subject to winner verification requirements.

If a prize is not claimed within the three months claim period, the prize, or a cash amount equal to the manufacturer's suggested retail price where required, will be donated to a charitable beneficiary approved by AGLC.

### **10. 50/50 Prize**

The 50/50 winner will receive 50% of gross 50/50 ticket sales, and the remaining 50% will be retained by Women in Need Society of Calgary in accordance with the licence and AGLC Policy.

The 50/50 winner must claim the prize within three months of the draw date.

### **11. Technical Interruption**

If there is a power failure or technical issue affecting the electronic raffle system, ticket sales will stop and may resume only if the issue is resolved, the system is recovered, and sales are reconciled in accordance with AGLC Policy.

### **12. Privacy and Publicity**

By purchasing tickets, you consent to the collection of your personal information. Personal information is used for the administration of the raffle, winner notification, prize fulfillment, reporting as required by law and AGLC, and promotion of future WINS raffles.

Winner information may be disclosed as required for raffle administration, reporting, or as otherwise required by law.
